However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Prices do not include: Merchandise and Services that are not listed in packages, Overtime, Cemetery Costs, Cash Advances, Oregon State Filing Fee (\$30), Oregon Certified Death Certificates (\$25.00 each)

Professional Services

Basic Services of Funeral Director and Staff \$740

This is our basic charge to each family we serve for our professional expertise in assisting them with their funeral arrangements. It includes, but not limited to, a proportionate share of taxes, licenses, utilities and business expenses necessary to serve the public in a professional manner. Also included in this charge is the consultation with the family, clerical and administrative services, preparation and filing of necessary permits, consultation with the clergy, cemetery, crematory or common carrier and planning the funeral. There will be an additional charge for the direction and supervision of each service requested or required. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burial, and forwarding or receiving remains.)

Embalming \$645

Embalming is a chemical process which provides temporary preservation of the body and eliminates certain health hazards. A person licensed by this state must complete this procedure. Except in certain special cases, embalming is not required by law. Embalming maybe necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it such as a direct cremation or immediate burial.

Direct Cremation from \$980 to \$19,295

Our charge for direct cremation without any attendant rites or ceremonies includes basic services of funeral director and staff, transfer of remains to funeral home, refrigeration, care of body, transfer to crematory and crematory fee. State and local laws do not require a casket for cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are constructed out of cardboard.

New Offerings:

Aquamation (Alkaline Hydrolysis) and Terramation (Natural Organic Reduction)

This charge includes the basic overhead and necessary fees to carry out the local transfer of the deceased to the funeral home, temporary shelter of remains, filing the death certificate and obtaining a disposition permit. It includes consultation with the family, hydrolysis or terramation charges and the return of the processed remains to the funeral home. An outer enclosure is not required. An urn selection will be requested for final disposition or memorialization purposes.
