The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

New York State Disclosure

***The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise you selected.**

***This list may not include prices for certain items you select, such as cemetery charges or crematory services, flowers, and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items.**

Federal Trade Commission (FTC) Disclosure

Our charge for a direct cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory and necessary authorizations.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a fiberboard container or an unfinished wood box.

New York State Disclosure

If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials.

Direct Cremation includes the local transfer of remains to the funeral home, the services of the Funeral Director and staff, securing of necessary authorizations, local transportation by livery to the crematory, an alternative container for cremation and the return of the cremated remains to the funeral home.

In all, we offer two basic package services for direct cremations:

Direct Cremation with a cremation container supplied by the purchaser. (All such containers must meet any state or crematory requirements). \$ 3,745.00

- Direct cremation with an alternative container \$ 3,990.00

The direct cremation prices do not include the crematory charge.

DIRECT BURIAL / IMMEDIATE BURIAL:

Federal Trade Commission (FTC) Disclosure

Our charge for an immediate burial (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; and local transportation to cemetery.

We offer two basic package services for direct burials:

The first package includes the local transfer of remains to the funeral home, the services of the funeral director and staff, securing of necessary authorizations, basic local transportation by livery to the cemetery, and an alternative container. \$ 4,215.00

The second package includes the services as described above but with the burial container supplied by the purchaser. \$ 3,970.00

The direct burial prices do not include the cemetery charge.

Federal Trade Commission (FTC) Disclosure

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

New York State Disclosure

In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as direct cremation or direct burial. If you select certain funeral arrangements such as viewing or an open casket funeral, embalming may be required by the funeral firm.

It is the policy of the Funeral Home to prohibit the public viewing of unembalmed remains except for identification purposes by a legally responsible party. Embalming or refrigeration will be required on remains that are held at the Funeral Home for more than 24 hours before disposition.

OTHER PREPARATION (Excluding Embalming)

Preparation of the remains, unless selected, is not required for direct cremation or for direct burial.

Custodial care will not be charged on the days when embalming or other preparation of the remains occurs, visitation is held or a funeral service is conducted.

The charge for our services will be added to the total cost of the funeral arrangements you select. However, this charge will not be added to the cost for direct cremation, direct burial, forwarding of remains or receiving of remains because the prices for those services include this charge.

The charge does not include shipping charges or additional items of services, merchandise, facility use, and livery that the customer may wish to select.

Transportation beyond a local place of shipment will be charged as livery at a rate of \$4.95 per mile. Local point of shipment is up to 25 miles from the funeral home. Public Transportation by common carrier will be charged as a cash advance only \$ 3,745.00

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME:

This charge includes the basic transportation of the remains to the funeral establishment and/or place of local disposition, services of funeral directors and staff, securing necessary authorizations. The charges do not include additional items of services, merchandise, facility use and livery that the customer may wish to select.

Transportation beyond a local place of shipment will be charged as livery at a rate of \$4.95 per mile. Local point of shipment is up to 25 miles from the funeral home. Public Transportation by common carrier will be charged as a cash advance only \$ 3,255.00
