Our charge includes arrangement of funeral and consultation with family and clergy, coordination with cemetery, crematory and/or other parties involved in the final disposition; securing, preparation and filing of necessary notices, authorizations and consent including death certificates; assistance with government and other claim forms, as needed. This fee for our services will be added to the total cost of the funeral services you select. Such a fee is already included in our charges for direct cremation, immediate burials, and forwarding or receiving remains.

Embalming \$295.00

Except in certain special cases, law does not require embalming. Embalming may be necessary however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial. If you selected a funeral which requires embalming, such as a funeral with a viewing, you may have to pay for the embalming. You do not have to pay for embalming you did not approve if you selected arrangements such as a direct cremation or immediate burial. If we charge for embalming, we will explain why in writing.
