These prices are effective June 18, 2024 and are subject to change without notice.

The goods and services shown below are those we can provide our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. Families are welcome to select caskets and cremation containers from any source they choose; however, Advent does offer a substantial discount on our service charges when a family opts to purchase these items through Advent.

Professional Services:

Basic Services of Funeral Director and Staff \$ 2255

Our basic service charge includes, but is not limited to, staff to respond to initial request for service; conducting the arrangement conference with family or responsible party; preparation and filing of necessary permits and certificates; placement of up to two local obituary notices, planning service arrangements; coordination of service with cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Use of Facilities, Staff and Equipment:

Coordination, staff and direction of a graveside service \$ 600

Coordination, staff and direction of a funeral/memorial ceremony \$ 750

Coordination, staff and direction of funeral ceremony at outside facility \$ 750

Facilities and staff for a visitation/viewing \$ 750
(each day or portion thereof to a maximum of 4 hours/ \$125/hour each additional)

Visitation coordination, set-up and supervision at church or other facility \$ 395
(may be with or without the body present)

Embalming: \$895

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Please note: To protect the health of our employees and insure sanitary conditions for families and guests, it is the policy of Advent Funeral and Cremation Services to (1) require the embalming or refrigeration of individuals whose burial or cremation will occur more than 48 hours from the time a patient is taken into our care, and (2) to require embalming for individuals for whom an open casket visitation/viewing is selected.

Forwarding Remains to Another Funeral Home: \$ 4015
This charge includes basic services of funeral director and staff, embalming, transfer of remains from professional facility during normal business hours, and transportation to the airport (excludes shipping charges). This charge does not include visitation, rites or ceremonies prior to the forwarding of the body or casket/shipping container and is valid only for destinations within the continental United States.

Receiving Remains from Another Funeral Home: \$ 3275
This charge includes the basic services of funeral director and staff, transportation from local airport to the funeral home, and hearse to a local cemetery. This charge does not include visitation, graveside services, church services, rites, ceremonies or outer burial containers.

Immediate Burial: from \$3220 to \$28070
The charge for an immediate burial (without rites, ceremonies, services, visitation, or in-person identification) includes basic services of funeral director and staff, transfer of remains from a professional facility during normal business hours, casketing and transportation to the cemetery in a funeral van (not hearse). This charge does not include bathing, dressing, the use of facilities and/or staff for any visitation or ceremony, public or private, prior to burial.

Immediate Burial with container provided by purchaser \$ 3220

Direct Cremation: from \$3080 to \$7380
The charge for direct cremation includes basic services of funeral director and staff, transfer of remains from a professional facility during normal funeral home business hours, transportation to the crematory, and the crematory fee. This charge does not include the use of facilities for any viewing, public or private, prior to the cremation. State and local laws do not require a casket for direct cremation.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of fiberboard, cardboard or paper.

Alternative/cremation containers are required by the crematory and Maryland and Virginia regulations (which define a minimum cremation container). The minimum cremation container available is a cardboard container with cover and wax interior. A complete description of these containers is found under the heading "Cremation Containers" on our Casket Price List.

The family room at the crematory may be available with a minimum of 24 hours notice for a family's viewing of the commencement of the cremation (\$695 at the Alexandria crematory, \$495 at our Beltsville crematory).

Please note: If you choose to have a viewing/visitation/funeral service/memorial service, there are different and additional charges for these services. These charges do not include the medical examiner's fee, any other cash advance (other than the crematory fee), dressing, bathing, preparation or the use of the facility for viewing or visitation, public or private.

In Virginia, the fee charged by the medical examiner's office for cremation approval is \$100; in Washington, D.C. it is \$75, Maryland does not levy a charge.

For the return of cremated remains within 36 hours of the time of arrangement or conclusion of visitation/viewing/identification or service with the body present, please add \$275 in addition to any special transportation arrangements that you may request.

Legal requirements mandate that cremation may only be authorized by the next of kin, legal designee or personal representative/executor after appointment.

To protect the health of our families and employees, in-person identifications are for identification purposes only and are not intended to serve as visitations or viewings. To minimize exposure, in-person identifications are limited to a maximum of five family members for fifteen minutes.

For sanitation reasons and to comply with state regulations, Advent requires refrigeration for those whose burial or cremation cannot be accomplished within 48 hours of the time of transfer from place of death. Refrigeration will be charged at \$75/day or portion thereof.
