We are the only area funeral home that offers a program called "The STAR Class" (*see page 3*); which stands for Special Times Always Remembered. This innovative program is geared to focus on the younger members of the family who may be experiencing deaths for the first time. Toddlers to pre-teens have benefited from this ground-breaking service. There is no charge for this class; it is merely a reflection of our desire to help every generation of your family.

I. Professional Services

Basic Services of Funeral Director and Staff

Services included, but not limited to: Responding to the initial request for service; conducting the arrangement conference; preparation of biographical and statistical data; examination of financial settlement options; preparation and filing of papers, permits, and authorizations; coordination with those providing other services; preparation and placement of obituary notices; retention and care of remains prior to commencement of post-death activities; overhead expenses relative to our facility and operations, such as occupancy, administrative and equipment costs.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burial, and forwarding or receiving remains.)

- ◇ Disinterment services (within 5 miles) \$935.

Embalming

(including use of preparation room and sanitary care)

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. If you choose to have an embalming performed, the decedent may be embalmed at a location other than this registered mortuary.

No human remains may remain or unburied or uncremated in New Jersey for more than 48 hours unless embalmed or refrigerated. (N.J.A.C. 8:9-1.1)

Other Preparation of the Body

(including use of preparation room but excluding embalming)

- ◇ Hair coloring (not including the cost of hair color) \$60.

Celebrant Services

As more people search for a funeral ceremony that reflects personal uniqueness and express depth and universality of meaning, our funeral home provides the services of "Certified Funeral Celebrants".

This service is an ideal option for those not affiliated with a church or who may not wish to have a religious funeral ceremony. The Certified Celebrant can also cooperate with your clergy's efforts to create a meaningful tribute which can make the difference between a funeral and a celebration of the uniqueness of the life lived.

Celebrants will speak with family members as they share stories and memories of the life of the deceased. Through our many resources for readings, music and other special touches, we can transform your memories into a meaningful celebration.

- ◇ Celebrant \$435.
(includes family consultation, ceremony in the funeral home and concluding remarks at the place of committal if scheduled immediately following the ceremony.)
- ◇ Multi-day/location Celebrant \$545.

Viewing and Visitation

Graveside/Committal Ceremony (cemetery and/or crematory)

Sheltering of Remains

Applies only on days when no post-death or ceremonial activities occur and the funeral home is in the possession of the remains.

The STAR Class is a sensitive, caring approach to helping children understand the funeral process. The STAR Class contains words and images that are not usually a part of every day conversation for children or adults. Providing children with the opportunity to hear the words of the funeral process, to express feelings and concerns in a creative art activity, and to write a STAR message to their loved one who has died can give them a sense of power over this new experience and help allay fears about what the funeral is all about. 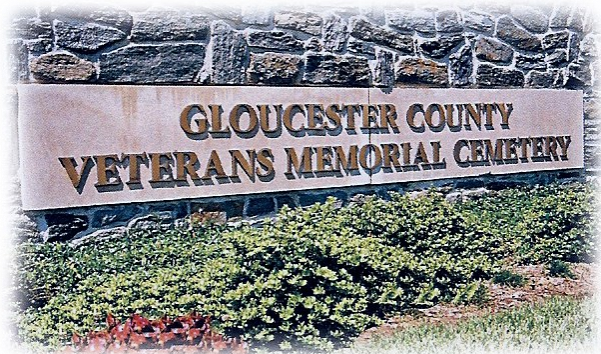

Consumer protection information: There are some monument/memorial dealers who, shortly after burial, contact the family and claim to represent the cemetery or the funeral home. These persons will often attempt to sell a monument to a family, receive payment, and fail to deliver, or suggest that there are certain requirements for monumentation and that the monuments must be placed within a certain period of time. **There are NO such regulations** requiring you to erect a monument or inscribe an existing one.

Forwarding of remains to another Funeral Home

\$3,835.

This package charge includes: local removal (within 5 miles) of remains to this funeral home, basic services of funeral director and staff, sheltering of remains for up to 48 hours, embalming and obtaining necessary permits. It does *not* include a casket or alternative or shipping container, the use of our facilities and staff for any visitation or ceremony, public or private, prior to forwarding the remains, or any sheltering for days on which no post-death activities occur. Nor does it include transferring the remains to the airport or other destination or the charges of a common carrier.

Receiving of remains from another Funeral Home

\$3,835.

This package charge includes: receiving the remains from another funeral home, sheltering of remains for up to 48 hours, basic services of funeral director and staff, obtaining necessary permits and authorizations and local transportation (within 5 miles) to the cemetery or crematory. It does *not* include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial or cremation, or any sheltering for days on which no post-death activities occur. Nor does it include transferring the remains from the airport or other source or the charges of a common carrier.

Immediate Burial

\$4,000. to 10,780.

Our package charges for immediate burial includes: basic services of funeral director and staff, transfer (within 5 miles) of remains to this funeral home, sheltering of remains for up to 48 hours, obtaining necessary permits and authorizations. Local transportation to the cemetery, sanitary care and preparation of remains for identification. This charge does *not* include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial, or any sheltering for days on which no post-death activities occur. Nor does it include the actual cost of the grave from the cemetery, or the cemetery's charges for opening and closing of the grave or an outer burial container (if required by the cemetery).

◇ Immediate burial with container (must meet cemetery requirements) provided by purchaser

◇ Immediate burial with an alternative container (minimum)

Direct Cremation

\$3,450. to 11,490.

Our package charges for direct cremation include: basic services for funeral director and staff, local transfer (within 5 miles) of remains to this funeral home, preparation of remains for identification, sheltering of remains for up to 48 hours, obtaining necessary permits and authorizations, and local transportation to the crematory. This charge does *not* include the use of facilities and staff for any visitation or ceremony, public or private, prior to cremation, or any sheltering for days on which no post-death activities occur or the cremation fee. If you wish to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering).

**The containers we provide are corrugated cardboard and/or fiberboard.*

In order to offer your family a dignified funeral for your loved one without interruption, we expect to receive full payment on or before the date services are rendered.

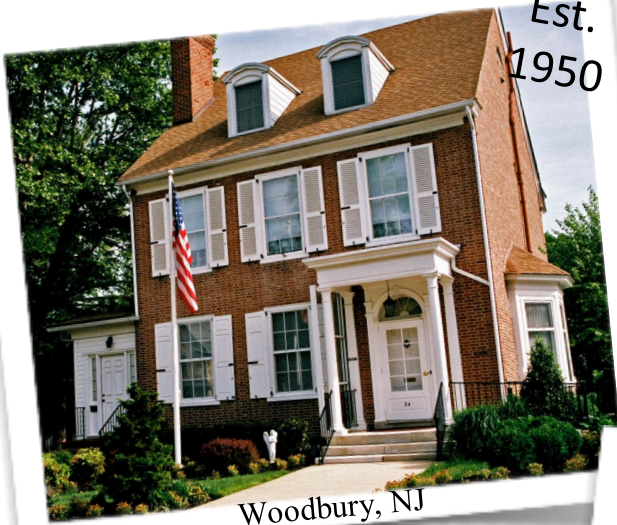
For families who have chosen to pre-arrange and have pre-funded their services through the **Forethought Insurance Company, Choices NJ Trust Fund or Homesteaders Life Company Funeral Insurance Program**, one of our licensed Funeral Directors will review the financial options and help gather paperwork necessary to claim the funds needed for the funeral. *If there is a difference in cost, we will review what needs to be paid by the date services are rendered, what can be returned to the beneficiary, or what goes to the State of New Jersey for recipients of Medicaid.*

The most direct way to ensure your loved one is taken care of financially is through cash, check, debit, or credit card. McGuinness Funeral Home will accept all major credit cards: **VISA, MasterCard, Discover, AmericanExpress, and also U.S. Cash, Personal checks, Bank checks, Cashier's checks, Business checks, and Money Orders.** *Due to reasons beyond our control, payments to third party companies such as: cemetery, crematory, musicians (organist, soloist, bagpiper, etc.), or individual clergy, a check may need to be written from a family member to that person/company directly; one of our Licensed Funeral Directors will prepare a list of who requires this and when it is needed.*

Some people may have one or more types of **life insurance**. Most insurance companies may take up to three months to release any funds to a third party such as McGuinness Funeral Home. A Licensed Funeral Director or Office Manager will help review the insurance policy, help gather needed information for processing, verify a policy is valid and active, file the necessary claim, assign the cost of funeral amount to the McGuinness Funeral Home, and help ensure any remaining funds are received by the beneficiary. *If you are using this policy to pay for the funeral, there is a **processing fee of 3% (\$100 minimum)** of the funeral cost, for this service.*

If your loved one was receiving public assistance in the form of **Medicaid** from the State of New Jersey, we will coordinate with the local Department of Health and Senior Services in accordance with the Work First New Jersey Manual to determine eligibility for financial assistance for the funeral. If your loved one is determined as being eligible, one of our Licensed Funeral Directors will review the financial options and limited offerings to which the State of New Jersey will allow. *Please ask us for more information if your loved one was collecting public assistance.*
