## **PROFESSIONAL SERVICES**

### **BASIC SERVICES OF THE FUNERAL DIRECTOR AND STAFF**

The fee for our Basic Services and overhead will be added to the total cost of the funeral arrangements you select. (a portion of this fee has been included in the charges for Direct Cremation, Immediate Burial and Forwarding of Remains). This fee includes the following: Available personnel 24 hours a day, 365 days a year to respond to the initial call, consulting and arrangement conference, coordinating arrangements with the cemetery, crematory and other final disposition, legal forms, permits, and notices. Overhead is included in this fee which may include, maintenance, inventory cost, liability insurance, and compliance cost.

#### EMBALMING

As provided by MN Stat 149.A, Subd.2:

"Except in certain cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial or when refrigeration or the use of dry ice is available."

### **Direct Cremation**

\$2,395 - \$10,025

Our charges for a direct cremation without an attendant, rites or ceremonies includes transfer of remains from place of death, transportation to the crematory, basic services of funeral director and staff, proportionate services selected, and cremation fee. *Federal Trade Commission Disclosure:* If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are corrugated fiberboard and hardboard. *Minnesota Disclosure:* Minnesota law does not require you to purchase a casket for cremation. If you want to arrange cremation, you can use a cremation container. A cremation container is a combustible, closed container that encases the body and can be made of materials like fiberboard body and can be made of materials like fiberboard or corrugated cardboard and into which a dead human body is placed prior to insertion into a cremation chamber for Cremation.
