 **PAYMENT POLICY**
Accounts are due and payable upon completion of the arrangement conference. In addition to cash and personal check, we accept Discover, Master/Visa card subject to bankcard approval.

OPTION #1 FULL PAYMENT
We require payment in full before the time of service. Cash advance items must be paid within 24 hours of scheduled service.

OPTION #2 INSURANCE ASSIGNMENT
Proceeds from one or more life insurance policies can be assigned to the funeral home for that portion that is owed. We will waive the late charges if receipt of the assigned insurance proceeds takes longer than 30 days, as long as payment is received within 45 days. A one time filing fee of \$235. is made to verify the policy, complete all forms and forward to the insurance company(s). Insurance policies must be verified during the arrangement conference and the due date on the funeral home purchase agreement will be set for payment within 45 days. We will not be able to accept any life insurance policy still in its contestable period. This period is normally two years from the date of issue. This option is for Life Insurance assignments only. No other type of insurance including automobile accident insurance assignments will be accepted. Veteran's Insurance Life Polices (issued by the U.S. Government) is NOT assignable.

OPTION #3 FINANCING THROUGH OUTSIDE ASSISTANCE
There is no lending service available through the funeral home. However, we can supply you with direct contacts via outside lending institutions. All arrangements for outside financing must be handled directly through them. The funeral home is not involved in your application for their credit and is not a party to your application.
Interest charges will accrue after signature on agreement • Estate filing will have an additional charge • Delayed payment will have an additional charge • Returned checks will have an additional charge & you will be required to provide a cashier's check or cash payment

TRADITIONAL SERVICE

\$6,740

This charge includes the basic professional services of the funeral director and staff; transfer of deceased from place of death; embalming, dressing, grooming, cosmetology and casketing of the deceased; scheduled visitation period (up to a 4 hours) on one day and funeral or memorial service either in the funeral home or other facility the next day; service vehicle to obtain documentation; transport of deceased to local final disposition.

LIMITED SERVICE

\$6,075

This charge includes the basic professional services of the funeral director and staff; transfer of deceased from place of death; embalming, dressing, grooming, cosmetology and casketing of the deceased; scheduled visitation and/or funeral service in the funeral home or other facility (within a 2 hour period) on one day; service vehicle to obtain documentation; transport of deceased to local final disposition.

DIRECT SERVICE

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME

This charge includes the basic professional services of the funeral director and staff; transfer of deceased from incoming local location; unpacking, inspection and temporary shelter of deceased; transportation of deceased to local final disposition. *This charge DOES NOT include: graveside service; visitation or funeral/memorial ceremony, public or private, prior to final disposition; merchandise; transfer; or airline charges from place of origin.*

FORWARDING REMAINS TO ANOTHER FUNERAL HOME

This charge includes the basic professional services of the funeral director and staff; transfer of deceased from place of death; basic embalming; service vehicle to obtain documentation; transportation of deceased to local jetport. This charge DOES NOT include: airline charges; merchandise; visitation or funeral/memorial ceremony, public or private, prior to forwarding remains to another funeral home.

ADD GRAVESIDE SERVICE

This charge includes all of the above services, PLUS coordinating graveside service with clergy and cemetery; supervision of graveside service; transport and arrange flowers; staff and equipment necessary to conduct graveside service; oversee interment of remains at cemetery. *These charges DO NOT include embalming; cemetery costs; gratuities; use of facility and staff for visitation or funeral /memorial service, public or private, prior to burial.*

DIRECT CREMATION

\$2,365 to \$3,565

This charge includes the basic professional services of the funeral director and staff; transfer of deceased from place of death; refrigeration storage (for a minimum of 48 hours); service vehicle to obtain documentation; on site cremation process.

ITEMIZED SERVICE CHOICES

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangement you select will include a charge for our basic service and overhead. If legal or other requirements mean you must buy any items you do not specifically ask for, we will explain the reason in writing on the statement describing the funeral good and service you selected.

This list DOES NOT include prices for certain items you may ask us to buy for you, such as: cemetery costs; flowers; obituaries; airline charges; death certificates; honorariums; special printing; medical examiner fees or special orders that are provided on behalf of the purchaser. The prices for these items will be show on your statement of services describing the funeral goods and service selected.

PROFESSIONAL SERVICES OF FUNERAL DIRECTOR & STAFF:

\$3,080

This fee is for our basic services and overhead. It will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for traditional and limited services, direct receiving; direct forwarding of remains to another funeral home; immediate direct burial and direct cremation.

Our professional services include, but are not limited to:

- 24 hours a day – 7 days a week – 365 days a year availability to your needs
- Staff to respond to your initial request for service
- Consultation with family and/or other responsible parties
- Care and custody of the remains
- Arrangement of the funeral or memorial service
- Procurement, preparation and filing of necessary authorizations, permits and death certificate
- Preparation and placement of local obituary notices
- General administrative and record keeping
- Coordination with those providing or participating in other portions of the funeral, as required.

Also included in this charge are the fixed overhead expenses relative to our facilities including professional licensing, legal and accounting fees, insurance, wages/salaries, building and utility expenses, parking lot and grounds maintenance, taxes, equipment, furnishing and inventory costs.

EMBALMING

\$1,040

Except in certain special cases, embalming is not required by law. Embalming may be necessary however, if you select certain funeral arrangements, such as funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. For health and sanitation reasons, un-embalmed remains in public areas, will only be allowed with a closed casket.
